2024 CAMP ELIGIBILITY GUIDELINES

The following factors are considered when determining eligibility to receive a Summer Camp Scholarship:

1. The child must live in the Clarkston Community School District.
2. The child must be school aged.
3. The child's household income falls within USDA/Section 8 Guidelines.
